Main Responsibilities:	
♦	Communicate with the older person/coordinator regarding shopping required. This may be done over the phone or a note may be left in an agreed location e.g. doorstep/ windowsill.
♦	Arrive at the persons home at the agreed time.
♦	Wear ID badge if possible
♦	Wear gloves while shopping to protect yourself and to minimise the risk of passing the virus on.
♦	Shopping to be left on doorstep in bags of reasonable weight enabling the older person to lift and carry them into their home.
♦	Please contact the coordinator once shopping has been dropped off.
♦	Discuss any problems or difficulties with the Community Projects Officer as they crop up.

Volunteers will be asked:

Have you ever completed an Enhanced Disclosure Check through Access NI? If so, when and with which club?

If they have not completed this through Ulster GAA and are volunteering in a GAA Covid-19 Scheme, they will be required to complete their Enhanced Disclosure Application prior to commencement of position.

Do not enter the persons home and always keep a safe distance of at least 2 metres when at the persons home or while out shopping.

Do not undertake this role if you are feeling unwell or have an underlying health condition that could make you more vulnerable to COVID-19.

You will be required to provide the following details:

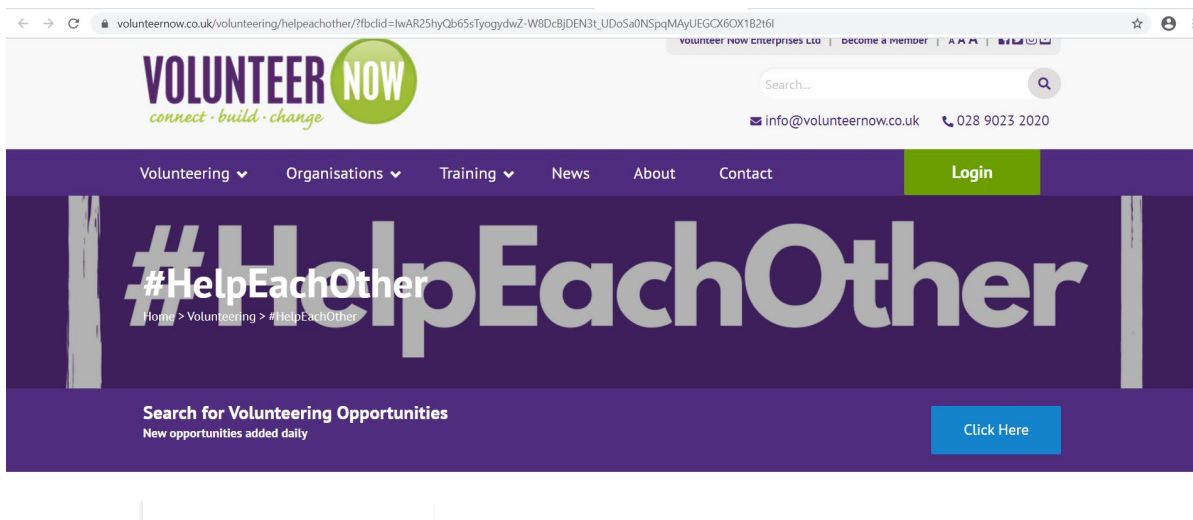
